1. Definitions

1. **TECHNICALLY VIABLE NUMBER OF SIMULTANEOUS CONNECTIONS:** The possible number of users, who can connect their PC to the provider of the WEBCASTING service. If the number of users is variable, a per month average is taken.

2. **WEBCASTING:** Broadcasting (streaming) of sound recordings/music videos, included only in an internet noninteractive radio/TV program, when the purpose of the service is not selling, advertising or promotion of certain goods and services except for sound recordings, live concerts or other musical events.

Notes:

THE NUMBER OF TECHNICALLY VIABLE SIMULTANEOUS CONNECTIONS IS PROVED BY:

1. Legal copies of the contractual technical data of the hardware used for webcasting
- and/or
2. Legal copy of the written statement with the description of the technical parameters of the hardware
- and/or
3. Legal copy of the technical description of the hardware for webcasting
- and/or
4. Legal copy of the technical description of the software for webcasting.

2. Discounts

Discounts for media groups – up to 15% of the monthly remuneration due as a lump sum (as per the decision of PROPHON's Board).

The discount for media groups is applied in cases such as:

- (1) Two or more noninteractive radio /television programs owned by one and the same contracting party
or
- (2) one and the same contracting party owns a decision-making quota of the equity of legal entities who manage, together or separately, two or more noninteractive radio-/television programs.

The discount for media groups is negotiated only if there are signed neighbouring rights licensing contracts with PROPHON for all Internet media (more non-interactive radio-/television programs), including those which launch broadcasting of programs on the Internet after the individual licensing contract has entered into effect. Otherwise, PROPHON does not offer any discount for media groups and the users must pay the total amount of the remuneration due.



3. Duration of the program:

The monthly remuneration amount is developed as a lump sum for 24-hour programs. Upon signing an individual contract with PROPHON monthly due remuneration is determined as a lump sum based on specific calculations for the program with its respective duration, which can vary within the 24-hour cycle. In such cases the remuneration due is determined as a proportional part of the remuneration for a 24-hour program, equal to the ratio between the actual duration of the program in hours and the maximum duration for the 24-hour cycle. The duration of a non-interactive program other than 24 hours is certified with explicit declaration by the user, an integral part of the neighbouring rights licensing contract with PROPHON.
